3. HAZARDS IDENTIFICATION:

Harmful in contact with skin and if swallowed. Causes severe burns. May cause sensitisation by skin contact. Very toxic to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

4. FIRST AID MEASURES:
